2026 PARENT FINANCIAL CONTRIBUTIONS

Parent Financial Contributions

Baradene College Limited is the Proprietor of the College and is responsible for the collection of Parent Financial Contributions which includes College and Junior or Senior Contributions.

GST Exempt contributions are authorised by section 34 of the Education and Training Act 2020 and qualify for the Donations Income Tax Rebate. A Donation Tax Receipt will be automatically posted out at the end of the Financial Year but is also available on request.

GST Inclusive contributions are authorised by section 30 of the Act and subject to GST at the current rate of 15% (subject to change by Government). These amounts do not qualify for the Donation Income Tax Rebate.

The first member of each family attending the College pays the full Financial Contribution (i.e., either the Junior or Senior Contribution). There is a discount of 5% for the second member of one family attending the College at the same time and, for the third and subsequent members of one family attending the College at the same time there is a discount of 10%. This discount does not apply to Attendance Dues, or College Contribution which are charged to all students.

The Boards of Baradene College have approved an increase equal to 3% of the total Parent Financial Contributions for 2026. This is to meet ongoing increases in costs and assist in the servicing and repayment of debt for the major capital project recently completed and ongoing development, details of which are set out below.

Attendance Dues

Attendance Dues (including GST) have been increased to \$281.00 per Term for senior students and \$136.00 per Term for juniors. The Minister of Education approves the rate of Attendance Dues under Section 30 of the Education and Training Act 2020 in respect of the groups of schools forming part of the Diocese of Auckland Common Fund. A portion of the Attendance Dues are paid to the Auckland Common Fund and the Attendance Dues must be applied solely for authorised purposes under Section 30 of that Act.

Junior and Senior Contributions

The Junior and Senior Contributions fund the Special Character Programme within the College, assist in the servicing and repayment of bank loans committed to by the Proprietor as part of the new developments scheduled in the Master Campus Plan, contribute directly towards the cost of large

and small capital projects and are used for general maintenance works around the College for which the Proprietor is responsible.

College Contribution

The College Contribution is \$387.83 (GST exempt) per Term. This Contribution is to cover extra resources for the benefit of students including additional staffing, curriculum resources, information technology and co-curricular activities.

Parent Teacher Association

The annual contribution of \$10.00 per family is collected on behalf of the PTA.

Alumnae Association

A one-off contribution of \$75.00 is collected from each Year 13 student on behalf of the Alumnae Association. This is for lifetime membership of the Association.

Master Development Plan

The Master Development Plan is subject to ongoing review to ensure the provision of high-quality teaching and learning facilities and to accommodate the school's increasing roll. It seeks to ensure that future capital works, following the completion of the Gymnasium and Café projects, are appropriately co-ordinated and prioritised. Parent Financial Contributions may be adjusted periodically to reflect rising costs, and the Boards reserve the right to implement such revisions during the year, following appropriate notification to parents.
